A Mother's Unyielding Love Transforms Pain into Progress (Bianca's Law)

A mother's love for her abducted daughter spans nearly three decades, driving her to fight for justice and inspire change.

When Deana's daughter, Bianca, was only 18 months old, her father took her for a court-ordered visitation, but he never returned. Instead, her father whisked Bianca off to Mexico, plunging her and her mother into a heartbreaking nightmare. The anguish and sorrow that followed would become an excruciating chapter in this courageous mother's life. With the help of private investigator Mark Stephens, Deana located her long-lost daughter in Mexico. Their emotional reunion at a Mexican police station in August 2021 brought hope for Hebert. However, the meeting exposed the painful consequences of parental alienation and flaws within the legal system.

Despite reaching adulthood, Bianca faces numerous challenges in considering reconciliation, primarily due to the psychological manipulation she endured from her father. Alienated adults often undergo significant emotional trauma and distress. The prospect of reconnecting with her mother may trigger fears of reopening past wounds or facing more emotional turmoil.

Bianca's father, Juan Antonio Lozano, couldn't be prosecuted for interfering with child custody due to the statute of limitations.





Furthermore, Mexico declined to extradite him to Texas, leaving Bianca vulnerable and cut off from her mother. This heartbreaking situation underscores the necessity for legal reform to safeguard children in similar situations.

Fueled by her desire to shield other families from the same pain, Deana fought for change. Almost 28 years later, in May 2023, <u>Bianca's Law</u> passed. In June it was signed into law and is officially known as House Bill 3025. The law brings newfound hope for parents and children who are suffering from the trauma of parental abduction and parental alienation.

Texas Rep. Cody Vasut and Senator Mayes Middleton championed the bipartisan-supported law that tackles two critical issues. Firstly, it removes the statute of limitations for prosecuting individuals who violate child custody orders by taking children out of the state. Secondly, it extends the prosecution period for kidnapping minors until the child's 18th birthday, preventing abductors from evading justice. This landmark legislation, now effective in Texas, seeks to foster stronger cross-state cooperation and smoother processes.

Although Bianca's Law will not immediately resolve the pain and loneliness experienced by families with missing children, it serves as a beacon of hope for the future. STL is honored to have Deana as one of our parent advocates. She plays a crucial role in raising awareness and advocating for the rights of missing children and their families. For the kids!
